
CLUB Registrar

Despite COVID-19 and the various challenges that we faced, registrations across the Club were actually higher than in the previous season & the pace was fast and furious! With the restrictions came challenges, it was actually the perfect opportunity to force the online process for every member, paving a much simpler process for the years ahead. In taking the role of registrar back on this season after a 3 year break, I would personally like to thank Kate Kelly for her awesome work over the previous few seasons which she primarily did on her own - no easy feat with 6 kids in tow.

While there were some frustrations in the SLSA system, it is pleasing to see the software improve each year. We managed to work through the odd glitch or two to get a pleasing result. Notably, this season saw the change to incorporate the redemption of the Active Kids via the SLSA portal which was a huge time saving in the registration space from previous years. Thanks very much to our office administrator, Lucy Russell, who came to my rescue early in the season and thanks to the Board for allocating her as a resource. Some rapid training soon helped to lighten the load. Total registrations for this season are 1559 - up by 40 from previous year, with Nippers only 20 less than the previous year despite having to slow down taking registrations as our U6's & U7's reached capacity numbers for Covid restrictions.

Plans for the coming season are to simplify the fee structure and maximise the Active Kids vouchers for all of our school age members. We will provide some simple steps for renewing and new memberships and also answer some FAQ's. A main takeaway from this season has been for those Nippers who are transitioning to Cadets and needing to continue with online education under their own SLSA logins whilst remaining in a Family Group. Providing instruction to the Education team should make this a better process next season. Thanks to all the members for their patience and support over the past season and we look forward to a great season ahead.


PRESIDENT'S report



The overall commitment of our surf club's dedicated voluntary surf lifesavers whilst doing their designated patrol duties, was once again of the very highest standard and I would like to both thank and congratulate every one of them for giving up of their personal time to serve both our surf club, as well as the general public in our local Sydney Northern Beaches community.

Most people are extremely busy these days with their numerous life requirements, including family obligations, work and/or school commitments and various other interests. Therefore, this selfless giving of one's time and efforts voluntarily whilst on rostered patrol duties to ensure that North Curl Curl Beach is kept safe during all of the weekends and public holidays from the end of September through to the end of April, should never ever be taken for granted nor underestimated by anyone.

North Curl Curl S.L.S.C. completed the 2020/2021 surf patrol season on Sunday, 25th April, 2021 with 224 patrolling members (129 males and 95 females), including 160 Bronze Medallion holders, 61 Surf Rescue Certificate personnel and 3 Award Members, with this being our club's highest ever combined total of rostered patrolling members. Of these 224 patrol members, 109 were 20 years old or over and predominantly male (82 to 27), with 115 being teenagers and primarily female (68 to 47). Also, 50 (that is, over 20%) of all of our surf club's patrolling members were 100% patrol efficient for this past 2020/2021 season, with their names being recorded at the end of this Annual DSL Report.

The organising and conducting of surf lifesaving activities in any surf club can be a most complex and time-consuming task. Therefore, I would like to thank and commend all office bearers in our surf club's surf lifesaving portfolio for their conscientious efforts over this past 2020/2021 surf patrol season.

Also, my sincere appreciation goes to our surf club's fourteen diligent Patrol Captains, in Rhiannon Stevens, Ross Tillman, Carmel Howard, Michael Jones, Simon Spicer, Ben Pardoen, Greg Stretton, Jamie Howieson, Andrew Mackenzie, Alan Prictor, Ben Dreghorn, Frederic Leforestier, Sarah Wanden and Duncan Grady for their excellent contributions to North Curl Curl S.L.S.C. as the leaders of their respective patrol teams.

With so many outstanding patrol teams in operation, the selection for the Best Patrol Team for the 2020/2021 season was once again an extremely difficult decision to make, However, for its overall team attitude, commitment, punctuality and performances whilst on the beach and at the water's edge, this prestigious and highly sought after patrol award was won by Patrol No. 10, with several other patrol teams coming very close runners up.

The Mark Watson Memorial Award for the Best Patrol Person of the Season award was most deservedly won by Ben Dreghorn on Patrol No. 11. Ben joined patrols as an SRC (known back then as an SLSC) in the 2001/2002 season at the age of 13, has been doing patrols continuously since then for the past 20 years and is now a conscientious and diligent Patrol Captain. Ben always arrives very early for patrol, is extremely vigilant whilst on patrol and leads by his wonderful example to all patrol team members.

Andrew Mackenzie (Patrol No. 9) has achieved this past season's award for the Best Patrol Captain due to his very thorough organisation of his patrol team members and facilitation of their respective endeavours. Andrew is also acutely aware of how important his patrol team's younger members are and ensures they are always involved and appreciated - very well done, Andrew.

Two seasons ago, two new awards for the Best Junior Male and Female Patrol People were introduced for our surf club's patrol members and the recipients of these awards for the 2020/2021 season were Skye Currie and Jamie Swane.

Skye who has won this award in consecutive seasons completed 48 patrol hours for the past season and as a Patrol Vice-Captain was very focused and pro-active with respect to all of her duties.

Jamie not only gained his IRB Driver's license during the course of the season, but also, similar to Skye, displayed a fine attitude and commitment towards all of his surf lifesaving endeavours.

In November, 2022, North Curl Curl S.L.S.C. will be celebrating its 100th Anniversary. Whilst our surf club has made numerous outstanding achievements and gained first class outcomes during its history, the thought of gender inequality still does concern me.

Over the almost 100 years of its existence, there has never been a lady in the Club Captain (or Director of Surf Lifesaving) role. Furthermore, currently 45% of our surf club's patrolling members are female, yet there are currently only three out of fourteen lady Patrol Captains (that is, less than 25%) and two out of thirty-six (or less than 6%) lady IRB Drivers. It is totally appreciated and understood that ideally the most suitable person or people should fill the various club roles, irrespective of gender, but hopefully over the next decade this noticeable inequality can be rectified.

As this DSL Annual Report draws to a close, I wish, as usual, to once more thank and acknowledge the members on our surf club's Board of Directors for their fine commitment and for the huge amount of work done by them in the various duties they have each needed to perform in their respective portfolios.

From a personal viewpoint, my gratitude goes to my brother and Club Life Member, Stuart Wye, for both the guidance and assistance that he readily affords me on so many occasions. Also, my gratitude goes to Lucy Russell (Club Assistant) for her ongoing assistance over the 2020/2021 season in providing me with much needed patrol documents and other patrol resources.

To serve North Curl Curl S.L.S.C. in the role of Director of Surf Lifesaving (or Club Captain) has once again been a huge honour and privilege and if it is the wish of our surf club's members,

I would very much like to complete the final season of my current four-year tenure in this role during the new upcoming 2021/2022 surf patrol season.

Finally, as usual, I wish to acknowledge the accomplishments of my dearly loved mother, Isabella Jessie Wye MBE OAM who was and always will be the major inspiration and motivation for everything I do in life, especially within the wonderful domain of voluntary surf lifesaving for our cherished surf lifesaving club.

EDUCATION

In a season like no other, we can be extremely proud of the way the education team at North Curl Curl responded to the challenges at a club, branch and state level. In my first year in the role of Director of Education I could not have hoped to work with a more talented, passionate and dedicated group of trainers, facilitators and assessors who have delivered some fantastic outcomes for the members of North Curl Curl Surf Life Saving Club.

I must give a special thanks to the amazing Clare Hagon for her tireless efforts and dedication in her pursuit for positive educational outcomes for every member of North Curl Curl. Over the last twelve months Clare's skills and experience has helped in the upskilling of our Training Team in the new SRC and Bronze course content and resources. The new course includes more online and interactive components. She has also undertaken training through Surf Lifesaving NSW, in the new mode of delivery – Canvas online - for the Training Officers Certificate, which Clare facilitates at a Branch level. I would also like to personally thank her for the warm welcome I received upon commencing this role and her patience and support in getting me up to speed the fastest possible way.

Season 2020/21 saw a number of changes in the education space, including course content, the way courses are delivered and changes to the way we maintain member skills through the annual proficiency process. Delivering these changes with the backdrop of COVID-19 proved challenging for many, however, I must thank each and every member of our education team for the manner in which they were able to implement these changes, ensuring a COVID-safe environment with positive member outcomes.

Skills maintenance & keeping our members proficient

With a number of SLS member services moving to the online world, 2020/21 saw an increased usage of the e-learning platform in the delivery of content. This season involved some significant changes in the skills maintenance process, including the migration of a number of key outcomes online, enabling our assessors and delegate assessors to re-imagine how they conducted this season's skills maintenance / proficiency sessions. Over six weekends, from late October through to December, our assessors ran 24 Surf Rescue Certificate (SRC), Bronze and IRB proficiency sessions and three ART proficiency sessions. Scheduled to coincide with the change-over of patrol teams each weekend allowed the team to conduct these sessions in a COVID-safe manner while also capturing members before or after their patrol. While this increased the pressure on the greater education team, the feedback from members has been overwhelmingly positive and the lessons learned will enable us to refine next seasons program.

A special thanks must go to the team who delivered these sessions including — Steven Atkins, Phil Godbee, Clare Hagon, Michael Jones, Frederic Leforestier, Ray Merton, Matt O'Connor, Lucy Russell, Anna Silva, Natasha Spencer, Matt Truman, Sarah Wanden, Alex Wye and David Young for their amazing efforts this season in ensuring we overcame the challenges and completed our skills maintenance program.





EDUCATION

Delivering SLS award courses

During a disrupted season at North Curl Curl Surf Life Saving Club, we were able to continue to deliver training courses for our club members. Providing opportunities to be trained in the skills required to be Life Savers, continues at the heart of what we deliver as a Surf Life Saving Club. Through the season the education team, including Steven Atkins in the role of lead Bronze and IRB trainer, Clare Hagon, Michael Jones, Ray Merton, Tony Tier, Sarah Wanden, Michael Wasley and Alex Wye continued the proud education tradition at North Curl Curl.

Season 2020-2021 saw the provision of award courses in SRC, Bronze Medallion, Senior First Aid, IRB Driver and IRB Crew Certificates. This included a trial of an intensive SRC course facilitated by Tony Tier and Michael Wasley during the term three school holiday period, the completion of SRC and Bronze Medallion courses that had been on hold since February (led by Steven Atkins), changes to the delivery of First Aid renewals and the incorporation of an SRC course into the under 14 nipper program as a bridge into the senior club.

I am pleased to report that despite this season's challenges, award attainment remained strong, including:

- Surf Rescue Certificate: 32 members
- Bronze Medallion: 28 members
- IRB crew: 1 member
- Silver Medallion IRB driver: 3 members
- Training Officer Bronze medallion: 1 member
- Provide First Aid: 65 members (including renewals)



One of the areas I am passionate about is capturing the expertise we have in the Club to assist in the training and development of our members. During the course of the season, the education team were fortunate to benefit from the skills and experience of subject matter experts to assist in skill development across various SLS disciplines. These fellow members included: Saul Brown, David Jones, Frederic Leforestier, Matt O'Connor, Glenn Slater, Matt Truman, Vanessa Wallace, William Wallace, Kurt Wegenaar and David Young. A special thanks also to Maryanne Troop and Gary Beauchamp from First Aid plus. Their close association with the education team and the facilitation of the Provide First Aid certification aligned with our Bronze Medallion courses and the renewal of existing award holders to ensure our patrolling members are set-up for success.

A Special Mention

During the course of the season many of our education team were active across the Branch in an assessor capacity, supporting the certification of Sydney Northern Beaches members in SLS awards, including: Steven Atkins, Clare Hagon, Ray Merton, Tony Tier and Michael Wasley.

One course we were unable to pick-up where we left off after the COVID break was the Gold Medallion group who were almost ready to face the rigors of assessment as the world went into lockdown. With the amount of work that went into getting to that point it would be awesome to see that group re-convene in the future when they are ready and attain their award.

Finally, from myself and the education team, thank you to David Wymer and the North Curl Curl SLSC Board for their assistance through the season. Their knowledge, strategic thinking and encouragement is an asset to our club, and I look forward to a successful season ahead.

Branch Results

Perception is reality! The feedback from officials and other club representatives was NCC competitors are respectful to fellow & other club competitors, polite & thankful to officials, and were obviously having fun. Hard not to have fun when surrounded by NCC supporters cheering their friends on.

A couple of the highlights where the North Curl Curl U10 Female board competitors winning 1st, 2nd, 3rd, 4th, 5th & 6th + gold in beach relays, flags, and R&R are just some examples of our remarkable talent coming home with 697 points. 159 points in front of our nearest rival.

There are so many great results from our 48 Beach and 77 Water competitors, the stats tell the story.

The NSW State Titles Wrap - The Junior State Titles for 2021 looked vastly different to those held in 2020, but that didn't change the result. In another dominant team display. North Curl Curl Nippers retained the NSW State title by an impressive margin.

Despite the disruptions to the 2021 season due to COVID restrictions, North Curly once again sent a well-prepared team of kids north to defend their title. While NCC arrived with a reputation for an immensely strong water team, this year saw the emergence of a competitive Beach and R&R team as well, coached and managed by Mike Girvan, Sophie McGovern, Justine Hayward-Smith and Rhonda Lycett. This presence allowed NCCs U9s-11s to build the points score in and out of the water on Days 1 and 2, under the watchful and occasionally teary eye of their coach, Andrew 'Dinky' Dennehy.

In some of the most challenging surf conditions seen at Swansea at State. Thursday provided thrills, spills, tears and laughter for the NCC Young Guns as they took on powerful surf that would've tested the most experienced of Open competitors. There were incredible performances from the brave group of NCC U9s, where it was a badge of honour just to get out and around the cans. The next generation of NCC Nippers showed they have the heart and the determination to represent their club in the years ahead. Across the 10s and 11s, the gold rush began for NCC and that would continue throughout the 4 days of competition. Friday was Team Day for the U9s-11s and with improving surf conditions, we saw just where NCC's strength lies. Across the age groups, points started accumulating as the Green and Gold continually crossed the line in point scoring positions. With the Juniors having set the tone, it was time for the Senior Nippers to follow their lead on Saturday and Sunday...and boy did they deliver. With some outstanding performances in the individual events, NCC went into the lead in early competition on Saturday morning and were never headed. Izzy Higgs secured her first State individual medal, securing bronze in the Board, against a stellar field of NSW competitors. NCC Head Coach, Michael 'Cluesy' Clues summed up what it meant when he said, "To see that smile and see her parents in tears, that's everything to me". Dominant duo, Olivia Clues and Dominique Melbourn completed a clean sweep from U11 to U14s in the Board Rescue. It was an outstanding performance from these NCC stalwarts and alongside their team mates, the Overall point score victory was settled. Our director of Surf Sports, Glenn Slater is fond of saying 'Everyone is a someone at North Curly' and this has never been more evident in 2020/21, as so many people played a role in bringing the title back to NCC; from behind the scenes organisation, to age managers, water safety, officials, kit organisers, trailer pullers, tent erectors, parents getting the kids to training and of course, the coaches. Without this huge team of people working together, these champion kids couldn't do what they did.

The installation should be taking place with a local supplier in the coming months.

Another season of challenges, no bushfires just COVID and floods but we had Branch, State and Aussies Championships!

This season was a season of firsts for our club highlighted by -

- 1^{st} Place NCC Overall Sydney Northern Beaches Branch Champions
- 1st Place NCC Sydney Northern Beaches Age Nippers Branch Championships (3 years in a row)
- ${\tt 1^{st}}$ Place NCC Sydney Northern Beaches Masters Branch Championships
- 2nd Place NCC Sydney Northern Beaches Opens Branch Championships
- 2 x Open Boat Crews competing in Ocean Thunder Series (Open Men's and Open Women's)

Club Investment in Coaching Structure Paying Dividends

The continued investment in our Surf Sports Coaching infrastructure is paying dividends with a clear improvement at all levels of development including beginner Nippers, our beach sprinters (1&2km runners), Junior R&R teams, U15's, U17's particularly our ski paddlers and our Boat Crews.

This investment is creating stronger more water capable lifesavers with ever-increasing numbers of nippers now completing their SRC and beginning their "voluntary surf lifesaving patrol" career, and a number of new boat rowers obtaining their bronze qualifications significantly contributing to the overall health of our club's patrolling numbers.

Particularly pleasing is that our U17 and U19 surf sports competitor numbers are also increasing rather than decreasing which has been the previous trend. This retention allows these members to gain more valuable patrolling experience and contribute to broader club life, vital for the long-term sustainability of our club.

A clear example of our how our program is developing is the NCC attendance numbers at the recent Youth Australian Titles. In 2019 NCC had 4 representatives, in 2021, NCC had 22 representatives.

Opens Branch – Palm Beach – Water

A big and mean surf greeted the Opens at Palm Beach. For the first time in history, we had 2 teams enter the Lifesaver relay with one qualifying for the State and Aussie Champs

Our numbers in 14 & 15 youth were particularly strong as was our U17 and U19 Female Teams which contributed to our strongest ever overall position in for nearly 25 years – We placed second to Newport, with Manly 3rd.

Our fantastic results again could not have been achieved if our members did not back up at the Beach branch titles and race in as many beach events as possible, Flags, Sprints, relays, 1 & 2km relays.

"The financial results for the year were solid"







Members, in presenting this year's annual financial report, I am fortunate to be part of a club that has demonstrated resilience, passion and drive in yet another challenging season.

This year's exceptional financial performance is the result of the work of so many volunteers, members, donors and sponsors that have combined to ensure the Club continues its role in providing safety and community to all who visit North Curl Curl beach.

This financial year (1 May 2020 to 30 April 2021) has seen the Club produce a net profit of \$73,054 and an increase its cash reserves from \$208,658 at 30 April 2020 to \$352,065 at 30 April 2021. A hugely positive result and evidence that the Club is preforming incredibly despite the challenges bought about by the pandemic.

As expected, the lockdowns caused by the continuous impact of Covid-19 on our community and wider society as a whole has forced significant disruptions to some of the Club's key profit centres. This includes impacts on the bar and hall hire as well as clothing sales and the golf day, but perhaps the most disappointing of all was the cancellation of this season's 3 Point Challenge.

Despite these disruptions to both the current operations and planning of future events, gross sales of \$34,540 in Clothing, \$70,546 for the Bar and \$10,102 for Hall Hire were still achieved. The standout of the season however was Saul Brown and his marketing team whom managed to secure close to \$40,000 in additional sponsorship and marketing funds. This income being the main contributor to the best profit the Club has seen in a number of years.

The overall position and results for the Club however speaks to the great work of all the dedicated volunteer works of the members, the portfolio leaders. A particular mention here of Chris Sparkes who has demonstrated ingenuity and dedication over this season being able to maintain social and bar revenues despite forced closures on key dates.

In addition to his work for the bar, Chris Sparkes and David Quinn also managed, with great success, the organisation and rescheduling of our clubs annual golf day which posted a net profit of \$29,539. This was a great event with the opportunity for our club members to connect and socialise after a challenging season and I thank both Dave and Chris for the great lengths they went to in making it all happen.

I would also like to take this opportunity to highlight the strong continued growth of our member's subscriptions and surf sports income.

Our registrar, Julie Tassone, along with the rest of the team has done an enormous job in attracting new members as well as maintaining our current ones for the 2020-2021 season. This has resulted in our strongest ever membership income performance of \$113,451, continuing the stable upward trend from \$106,665 last year.


Glenn Slater and the rest of the coaches, water safety and volunteers such as Andrew Stuart have once again seen the Club's Surf Sports activities be a key contributor to the Club's member base, which resulted in \$6,909 in equipment hire income and \$18,116 in carnival and competition income. Despite the disrupted competition season, this is up from the previous season's figures of \$3068 and \$13,700 respectively.

Notes to the Financial Statements

North Curl Curl Surf Life Saving Club For the year ended 30 April 2021

Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009 (NSW), the Charitable Fundraising Act 1991 (NSW) and the Australian Charities and Not-for-Profits Commission Act 2012 (Cth) and the club's constitution. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared in accordance with the requirements of the above acts and regulations, the club's constitution and the following Australian Accounting Standards:

AASB 101 Presentation of Financial Statements

AASB 107 Statements of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1031 Materiality

- AASB 1048 Interpretation of Accounting Standards
- AASB 1054 Australian Additional Disclosures

No other Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets. The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

No provision for income tax has been raised as the Association is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

In the event the carrying value of plant and equipment is greater than the estimated recoverable amount, the carrying value is written down immediately to the estimated recoverable amount. A formal assessment of recoverable amount is made when impairment indicators are present.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of comprehensive income during the financial period in which they are incurred.



Depreciation

The depreciation method and useful life used for items of property, plant and equipment(excluding freehold land) reflects the pattern in which their future economic benefits are expected to be consumed by the association. Depreciation commences from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements. The depreciation method and useful life of assets is reviewed annually to ensure they are still appropriate.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value. Bank overdrafts are presented within current liabilities on the statement of financial position.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income



Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term. Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

Financial Instruments

Recognition, initial measurement and derecognition

Financial assets and financial liabilities are recognised when the Association becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and subsequent measurement of financial assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

amortised cost



- fair value through profit or loss (FVPL)
- equity instruments at fair value through other comprehensive income (FVOCI)

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The entities business model for managing the financial asset
- The contractual cash flow characteristics of the financial assets

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

Subsequent measurement financial assets

Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows

- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding

After initial recognition, these remeasured at amortised cost using the effective interest method. Discounting is omitted where the effect if discounting is immaterial. The Association's cash and cash equivalents, trade and most other receivables fall into this category of financial instruments as well as long-term deposit that were previously classified as held-to-maturity under AASB 139.

Financial assets at fair value through profit or loss (FVPL)

Financial assets that are held within a different business model other than 'hold to collect' or 'hold to collect and sell' are categorised at fair value through profit and loss. Further, irrespective of business model financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVPL. All derivative financial instruments fall into this category, except for those designated and effective as hedging instruments, for which the hedge accounting requirements apply (see below).

Equity instruments at fair value through other comprehensive income (Equity FVOCI)

Investments in equity instruments that are not held for trading are eligible for an irrevocable election at inception to be measured at FVOCI. Under Equity FVOCI, subsequent movements in fair value are recognised in other comprehensive income and are never reclassified to profit or loss. Dividend from these investments continue to be recorded as other income within the profit or loss unless the dividend clearly represents return of capital.

Impairment of Financial assets

AASB 9's impairment requirements use more forward looking information to recognize expected credit losses - the 'expected credit losses (ECL) model'. Instruments within the scope of the new requirements included loans and other debt-type financial assets measured at amortised cost and FVOCI, trade receivables and loan commitments and some financial guarantee contracts (for the issuer) that are not measured at fair value through profit or loss.

The Association considers a broader range of information when assessing credit risk and measuring expected credit losses, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.



In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ('Stage 1') and

- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ('Stage 2').

'Stage 3' would cover financial assets that have objective evidence of impairment at the reporting date.

'12-month expected credit losses' are recognised for the first category while 'lifetime expected credit losses' are recognised for the second category.

Measurement of the expected credit losses is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade and other receivables

The Association makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. In using this practical expedient, the Association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

Classification and measurement of financial liabilities

As the accounting for financial liabilities remains largely unchanged from AASB 139, the Association's financial liabilities were not impacted by the adoption of AASB 9. However, for completeness, the accounting policy is disclosed below.

The Association's financial liabilities include borrowings and trade and other payables.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Association designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss(other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in theassets and liabilities statement.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.



1. Related Party Transactions

Interest in Contracts

During the year the association entered into a contract with Navwealth Accounting Pty Ltd to provide accounting and taxation services to the association. Simon Prowse, who is a committee member of the association, is also the managing director of Navwealth Accounting Pty Ltd. During the year \$Nil was paid to Navwealth Accounting Pty Ltd for its service.

2. Subsequent Events

The World Health Organisation (WHO) declared the COVID-19 virus a global Health emergency on 30 January 2020. Global trade and markets have been significantly disrupted, and many businesses have had to, or will have to, limit or suspend their operations.

All global share markets have suffered significant falls since 30 January 2020. The committee have assessed the impact of the pandemic on the Financial Statements of the Association. There is no effect of the pandemic on the asset values as at 30 April 2020.

Responsibility of the Committee's for the Financial Report
