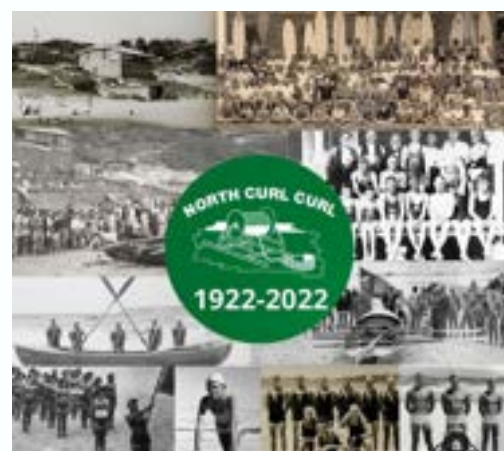

President's Report

I am delighted to present the Season 2022/23 annual report, our centennial year to the members of North Curl Curl Surf Life Saving Club. A massive amount of voluntary time is dedicated to the successful operation of our club, so to all my fellow Directors and Assistant Directors of the Management Board and their portfolio teams, - I say a big THANK YOU for everything you have done for our club.

Thankfully this season, has been a season of celebration as opposed to the challenges we faced last year.

Reflection and Appreciation

Before I start, I wish to reflect and pay tribute to our foundation members, Macklin, Boyt, the Aldridge and the O'Toole families for having the courage and the foresight to band together as a community and form North Curl Curl Surf Life Saving Club on the 3rd of November 1922.

I wish to acknowledge and thank the thousands of members who have patrolled our beach or been involved in the many activities of the club in the past 100 years, and I wish to express my gratitude to all the Club Presidents before me, from Macklin, Climo, Harry, Hirsch, Grew and Young in the early years to those who have been the Club leaders in my life time; Kevin Martin, Terry Arnold, Robert Agnew, Keith Smith, Stuart Wye, Dave Murray, Ian Thurgood, Rob Langbein, and David Wymer, for their selfless commitment and unwavering passion to doing their very best for the members of our club and our community as evidenced by another successful patrolling season where we again achieved "No lives lost" between the flagsour purpose for existence. You have all made significant contributions to our club in your own way and that is why our club has continued and prospered for the past 100 years and will do the same for the next 100 years.

Season 2022 / 23 a season of Celebration

Our season commenced with the weather system La Niña subsiding though leaving its impact on our beach with the loss of large amounts of sand from our northern basin,

exposing rocks and name carvings which hadn't been sighted for 30 years.

Centennial Surf Carnival

On the 28th of October we held our Centennial Surf Carnival, the first combined Board, Ski and Surf Boat Carnival held on our beach for over 20 years. This was a magic sunny day, with only a small swell, providing a perfect opportunity for all the boat crews, board and ski paddlers from Sydney Northern Beaches, Sydney Branch and the Central Coast to get in some hard racing.

Long Weekend Centennial Celebrations

Then we moved to the big one, our long weekend 25th to 27th November 2023 of Centennial celebrations which kicked off with a Friday Night "Bottles" reunion, where members admired the "Nola Hubbard" 1950's surfboat which was on loan from the Powerhouse Museum for the weekend.

Members old and new gathered to reminisce and tell stories, followed by our 100 year gala dinner at the DYRSL club on the Saturday night attended by over 350 members from across Australia, joined by local politicians and Surf Life Saving NSW hierarchy to pay tribute to our club.

Finally on the Sunday we had the unveiling of the time capsule that was concreted into the foundations of our club circa 1979 by club leaders at the time. After much excitement the capsule was cracked open by Life Members Jimmy Newton, Stu Wye, Chris Stoneman and Kevin Martin, its contents acting as well-preserved reminders of surf club activities in the late 70's, old swimmers, patrol equipment, copies of the Manly Daily, photos and letters from club leaders. With such a large crowd gathered to cut the 100-year cake, and open the time capsule it was only fitting that a sensational club photo be captured on the club steps marking the occasion...which it was!

Thanks to all the life members on the organising committee, and David Wymer for making the weekend such a memorable event.

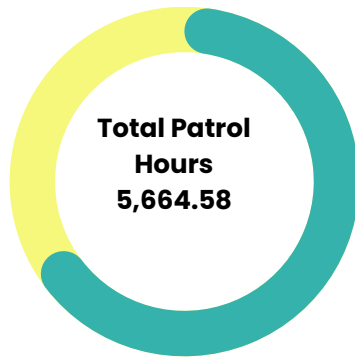

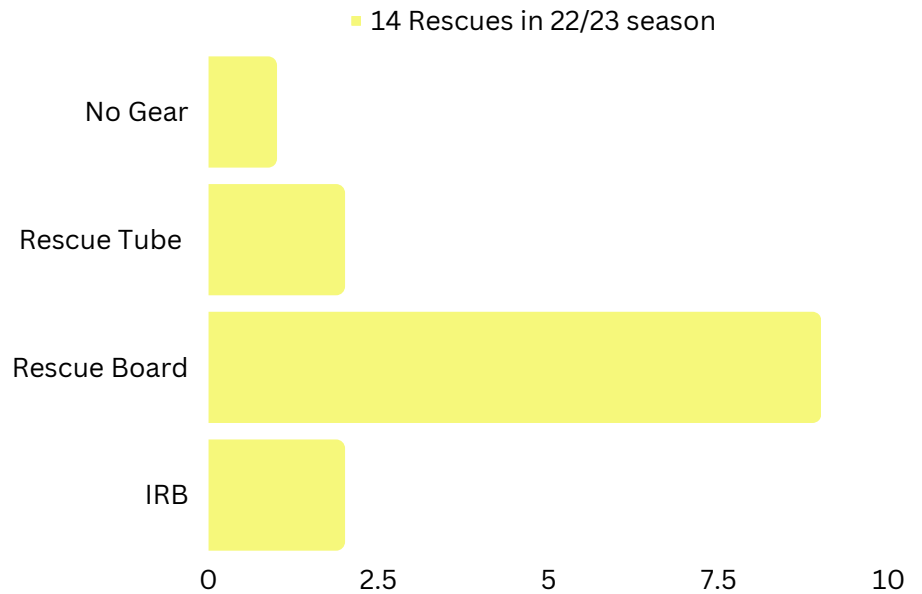

We have embarked on our new Youth and Community Program (YAC) this season, sponsored by VIVID Life Foundation, we are extremely grateful to Scott Agnew for his ongoing support of our Youth members. This has included the re-launch of Youth Nights, incorporating BBQ beach nights, volleyball, very competitive touch footie games and ping-pong and pizza during the cooler nights. The award acknowledges the contribution that youth members make to the club and the wider community and provides a financial award to finance their further vocational pathway. Our recent June club strategy day was a great opportunity for the board and committee members to plan for our future club strategy. It highlighted the strength of our volunteer community and the passion so many have for the club and the commitment to invest time and effort amounting to hundreds of volunteer hours to make the club what it is today. We are excited to embrace the ideas presented and continuing to improve the service we offer to our members for the upcoming season.

We recently celebrated youth at the Northern Beaches Awards of Excellence, our youth members included Kate Wagland nominated as Youth Volunteer of the Year for the second year running for her tireless efforts of going above and beyond for the greater good of our club and Luke Higgs for the Youth Athlete award, congratulations to you both on your nominations.

Finance

Members, as Director of Finance, I am pleased to provide my financial report.

In a return to normal activities, the club had a significant uplift in activity across all areas of the club. We thank our volunteers, members, donors and sponsors for working together to deliver a cash surplus for s members for the year.

The increased activity as the club returned to normal operations this financial year (1 May 2022 to 30 April 2023) ("FY2023") has seen the club experience a significant uplift in Gross Revenues of 17% over FY2022, even with a large drop in government grants related to Covid-19 support.

There was also an increase of 40% in Total Expenses over the prior period of which a large portion was the one off cost of the 100 Year Event, along with a general increase of expenses back to a level commensurate with pre-covid activities. While this resulted in a small net deficit of \$7,382 for the year, it was pleasing the club still generated a cash surplus of \$30,794 resulting in cash reserves increasing from \$374,825 as at 30 April 2022 to \$405,618 as at 30 April 2023.

For the first time in several years, the club was able to run its events such as the three-points challenge and golf day, which, while there was lower participation than pre-Covid years, it still contributed significantly to the operating cashflows of the club.

While there was a reduced contribution from Government grants and no Covid related stimulus in FY2023, there was significantly higher contributions from the bar, kiosk and hall operations and surf sports when compared to the prior period which were impacted by lock downs. This resulted in a significant increase in gross income for the year from \$453,719 in FY2022 to \$544,561 in FY2023. More specifically the key operating income items and their movement from FY2022 to FY2023 include;

- Member Subscriptions increased from \$104,419 in FY2022 to \$107,844 in FY2023, which, while pleasing, is still below pre-Covid levels.
- Sales in clothing increased from \$28,743 in FY2022 to \$46,991 in FY2023.
- Revenue from bar sales increased from \$66,663 in FY2022 to \$83,359 in FY2023,
- Revenue from Hall hire was up significantly from \$12,585 in FY2022 to \$33,213 in FY2023,
- Sponsorships and donations dropped slightly from \$69,068 in FY2022 to \$67,369 in FY2023, and we thank the sponsors for their continued support. This is discussed below in further detail,
- Carnival and competition revenues were up significantly from \$36,201 in FY2022 to \$87,130, which reflected a significant increase in carnival and competition activity in the year when compared to the prior year in which the competitor season was still impacted by restrictions. The large contingent of competitors who travelled to Western Australia for the Aussies contributed to this increase (revenue includes the contribution by members for accommodation in WA). It also reflects the continued impressive performance of the surf sports team and coaches in building one of Australia's leading surf sports team,
- Grant income dropped from \$72,742 in FY2022 to \$15,818 in FY2023, but it should be remembered that a large contribution was the grant in FY2022 which delivered a new solar system that was installed for the club.

There was no government stimulus payments for the FY2023 compared to \$30,050 in FY2022

Total expenditure for FY2023 was \$551,942 against \$393,155 for FY2022 which reflected an increase in all activities during the FY2023 season which was not impacted by any Covid -19 restrictions when compared to FY2022. As mentioned above, there were certain activities that contributed to the increase in expenses (when compared to prior years), including and not limited to:

- 100 Year event costs
- A write off of old outstanding receivables that were treated as bad debts.

Finance

Similar to last year, the work of marketing team has generated significant income for our club from sponsorship and donations. We can report donations and sponsorships of \$69,369 for FY2023. On behalf of Saul Brown and Manuela Curzon, plus the rest of the board and the club community as a whole I would like to extend a sincere thankyou to our benefactors including:

Notes of the Financial Statements

North Curl Curl Surf Life Saving Club For the year ended 30 April 2023

Summary of Significant Accounting Policies

The financial statements cover North Curl Curl Surf Life Saving Club as an individual entity. North Curl Curl Surf Life Saving Club is a not-for-profit Association incorporated in New South Wales under the Associations Incorporation Act 2009 (NSW).

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009 (NSW), the Charitable Fundraising Act 1991 (NSW) and the Australian Charities and Not-for-Profits Commission Act 2012 (Cth) and the club's constitution. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared in accordance with the requirements of the above acts and regulations, the club's constitution and the following Australian Accounting Standards:

AASB101 Presentation of Financial Statements

AASB 107 Statements of Cash Flows

AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors

AASB1031 Materiality

AASB1048 Interpretation of Accounting Standards

AASB1054 Australian Additional Disclosures

No other Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets. The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

No provision for income tax has been raised as the Association is exempt from income tax under Div 50 of the Income Tax Assessment Act 1997.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

In the event the carrying value of plant and equipment is greater than the estimated recoverable amount, the carrying value is written down immediately to the estimated recoverable amount. A formal assessment of recoverable amount is made when impairment indicators are present.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of comprehensive income during the financial period in which they are incurred.

Depreciation

The depreciation method and useful life used for items of property, plant and equipment (excluding freehold land) reflects the pattern in which their future economic benefits are expected to be consumed by the association. Depreciation commences from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements. The depreciation method and useful life of assets is reviewed annually to ensure they are still appropriate.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are recognised in profit or loss. When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value. Bank overdrafts are presented within current liabilities on the statement of financial position.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Financial Instruments

Recognition, initial measurement and derecognition

Financial assets and financial liabilities are recognised when the Association becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and subsequent measurement of financial assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments are classified into the following categories upon initial recognition:

- amortised cost
- fair value through profit or loss (FVPL)
- equity instruments at fair value through other comprehensive income (FVOCI)

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables which is presented within other expenses.

Classifications are determined by both:

- The entity's business model for managing the financial asset
- The contractual cash flow characteristics of the financial assets

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

Subsequent measurement financial assets

Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Association's cash and cash equivalents, trade and most other receivables fall into this category of financial instruments as well as long-term deposit that were previously classified as held-to-maturity under AASB 139.

Financial assets at fair value through profit or loss (FVPL)

Financial assets that are held within a different business model other than 'hold to collect' or 'hold to collect and sell' are categorised at fair value through profit and loss. Further, irrespective of business model financial assets whose contractual cash flows are not solely payments of principal and interest are accounted for at FVPL. All derivative financial instruments fall into this category, except for those designated and effective as hedging instruments, for which the hedge accounting requirements apply (see below).

Equity instruments at fair value through other comprehensive income (Equity FVOCI)

Investments in equity instruments that are not held for trading are eligible for an irrevocable election at inception to be measured at FVOCI. Under Equity FVOCI, subsequent movements in fair value are recognised in other comprehensive income and are never reclassified to profit or loss. Dividend from these investments continue to be recorded as other income within the profit or loss unless the dividend clearly represents return of capital.

Impairment of Financial assets

AASB 9's impairment requirements use more forward looking information to recognize expected credit losses - the 'expected credit losses (ECL) model'. Instruments within the scope of the new requirements included loans and other debt-type financial

assets measured at amortised cost and FVOCI, trade receivables and loan commitments and some financial guarantee contracts (for the issuer) that are not measured at fair value through profit or loss.

The Association considers a broader range of information when assessing credit risk and measuring expected credit losses, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk ('Stage 1') and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low ('Stage 2').

'Stage 3' would cover financial assets that have objective evidence of impairment at the reporting date.

'12-month expected credit losses' are recognised for the first category while 'lifetime expected credit losses' are recognised for the second category.

Measurement of the expected credit losses is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade and other receivables

The Association makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance

at the amount equal to the expected lifetime credit losses. In using this practical expedient, the Association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

Classification and measurement of financial liabilities

As the accounting for financial liabilities remains largely unchanged from AASB 139, the Association's financial liabilities were not impacted by the adoption of AASB 9. However, for completeness, the accounting policy is disclosed below.

The Association's financial liabilities include borrowings and trade and other payables.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Association designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss (other than derivative financial instruments that are designated and effective as hedging instruments).

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

Leases

Prior Treatment

Finance Leases were capitalised, recording an asset and a liability.

Leased assets were depreciated over their estimated useful lives. Finance leases were allocated between the reduction of the lease liability and the lease interest expense for the period.

Lease payments for operating leases, where substantially all the risks and benefits remained with the lessor, were charged as expenses in the periods in which they were incurred.

New Accounting Standards Introduced

AASB 16: Leases (applicable to annual reporting periods beginning on or after 1 January 2019) replaces the previous accounting requirements. AASB 16 introduces a single lessee accounting model that eliminates the requirement for lease to be classified as operating or finance leases.

The main changes introduced by the new Standard are as follows:

- recognition of a right-of-use asset and liability for all leases (excluding short-term leases with less than 12 months of tenure and leases relating to low-value assets);
- depreciation of right-of-use assets in line with AASB 116: Property Plant & Equipment in profit or loss and unwinding of the liability in principal and interest components;

Notes of the Financial Statements

- inclusion of variable lease payments that depend on an index or a rate in the initial measurement of the lease liability using the index or rate at the commencement date;
- application of a practical expedient to permit a lessee to elect not to separate non-lease components and instead account for all components as a lease; and
- inclusion of additional exposure requirements.

AASB 2018-8 Amendments to Australian Accounting Standards – Right-of-Use Assets of Not-for-Profit Entities allows that where

the lessee is a not-for-profit entity, the lessee may elect to measure right-of-use assets on a class-by-class basis at initial recognition at fair value in accordance with AASB 13 Fair Value Measurement for leases that have significant below-market terms

and conditions principally to enable the entity to further its objectives. AASB 1058 Income for Not-for-Profit Entities addresses the recognition of related amounts.

In addition, where a lessee is a not-for-profit entity and elects to measure a class or classes of right-of-use assets at initial recognition at cost for leases that have significantly below-market terms and conditions principally to enable the entity to further its objectives, the lessee shall disclose additional qualitative and quantitative information about those leases which shall

include, but is not limited to, information that helps users of financial statements to assess:

(a) the entity's dependence on leases that have significantly below-market terms and conditions principally to enable the entity to further its objectives; and

(b) the nature and terms of the leases, including:

(i) the lease payments

(j) the lease term

(k) the description of underlying asset; and

(l) restrictions on the use of the underlying assets specific to the entity.

The disclosures so provided by a not-for-profit entity shall be provided individually for each material lease that has significantly below-market terms and conditions principally to enable the entity to further its objectives or in aggregate for leases involving right-of-use assets of a similar nature.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Inventories

Inventories are valued at the lower of cost and net realisable value. No value is ascribed to goods for resale that have been donated to the Association where fair value cannot be reliably determined. Net realisable value is the estimated selling price in the ordinary course of business, less any applicable selling expenses.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

Significant management judgement in applying accounting policies

When preparing the financial statements, management undertakes a number of judgements, estimates and assumptions about the recognition and measurement of assets, liabilities, income and expenses.

Estimation uncertainty

Information about estimates and assumptions that have the most significant effect on recognition and measurement of assets, liabilities, income and expenses is provided below. Actual results may be substantially different.

Impairment

In assessing impairment, management estimates the recoverable amount of each asset or cash-generating units, based on expected future cash flows and uses an interest rate to discount them. Estimation uncertainty relates to assumptions about future operating results and the determination of a suitable discount rate.

Useful lives of depreciable assets

Management reviews its estimate of the useful lives of depreciable assets at each reporting date, based on the expected utility of the assets. Uncertainties in these estimates relate to technical obsolescence that may change the utility of certain software and IT equipment.

Inventories

Management estimates the net realisable values of inventories, taking into account the most reliable evidence available at each reporting date. The future realisation of these inventories may be affected by future technology or other market-driven changes that may reduce future selling prices.

Long service leave

The liability for long service leave is recognised and measured at the present value of the estimated cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

Related Party Transactions

The Association's related parties include its key management personnel and related entities as described below. Unless otherwise stated, none of the transactions incorporate special terms and conditions and no guarantees were given or received. Outstanding balances are usually settled in cash.

Transactions with related entities

During the year the association entered into a contract with Navwealth Accounting Pty Ltd to provide bookkeeping & accounting services to the association. Simon Prowse, was a prior committee member of the association, is also the managing director of Navwealth Accounting Pty Ltd. During the year \$Nil was paid to Navwealth Accounting Pty Ltd for its service,


